

**CORRIDOR RECOVERY—FLOOD CLEANUP ASSISTANCE SERVICES
VOLUNTEER RELEASE AND LIABILITY WAIVER**

IMPORTANT! READ THIS DOCUMENT IN FULL BEFORE SIGNING!

I desire to participate as a volunteer with **Corridor Recovery, an Iowa nonprofit corporation**, to provide cleanup assistance services ("**Cleanup Assistance**") to area residents and businesses whose properties were damaged as a result of the flood events of June 2008. I represent, acknowledge and agree that:

- (A) I am entering into this Volunteer Release and Liability Waiver (the "**Release**") freely and voluntarily, without duress, for the benefit of Corridor Recovery, an Iowa nonprofit corporation, its directors, officers, employees, agents, contractors, volunteers and constituent members, and their respective successors and assigns (collectively, "**Corridor Recovery**");
- (B) My participation is strictly voluntary, and without compensation. In performing Cleanup Assistance, I am not an employee of Corridor Recovery or any of its constituent members (irrespective of whether I may an employee of any such party for other purposes), and I will not represent myself as such. I understand that Corridor Recovery does not carry or maintain any health, medical, or disability insurance coverage, for its volunteers, and that I am expected to carry my own personal health insurance and liability insurance.
- (C) I am aware that Cleanup Assistance often involves hard physical labor, heavy lifting and other strenuous activity. I am in good health and physically able to perform this type of work. I am also aware that Cleanup Assistance will be conducted in environments that may be inherently dangerous or hazardous, and that this entails certain risks, including (but not limited to) accidents, bodily injury, illness or death, damage to property or other loss;
- (D) My participation in Cleanup Assistance is entirely at my own risk, and I assume all risk and responsibility for any property loss or damage, bodily injury (including death), personal injury, or illness that I may sustain as a result of my participation, including related medical costs and expenses. To the fullest extent permitted by law, on behalf of myself, my successors and assigns, I release and forever waive, and hold Corridor Recovery harmless from, all claims, causes of action, liability and damages that I now or hereafter have with respect to any property loss or damage, bodily or personal injury, illness or death that may result from or arise in connection with my participation in Cleanup Assistance;
- (E) I will at all times fully observe and abide by all Policies and Procedures established by Corridor Recovery with respect to Cleanup Assistance. Any questions about the Policies and Procedures will be resolved by the volunteer Team Lead on site, whose decision I will respect as final;
- (F) In the event of any emergency, I authorize the provision of any first-aid or medical treatment deemed necessary for my immediate care from any licensed hospital or medical personnel, and I will be responsible to pay for all such services. I release and forever discharge Corridor Recovery from liability for any and all claims arising on account of any such treatment or services.
- (G) I have the right to discontinue participation in Cleanup Assistance at any time and for any reason, in my sole discretion. If I choose to do so, I will notify my volunteer Team Lead of my decision as soon as possible. I understand that Corridor Recovery has the right to terminate my Cleanup Assistance volunteer services at any time and for any reason, in its sole discretion. My volunteer Team Lead has the authority to direct the entire team, or any individual member (including me) to leave a cleanup site at any time for any reason, and I will promptly comply with all such directions.
- (H) Corridor Recovery (the legal entity and each of its constituent members), shall have the right to use, for any legitimate purpose, any and all photographic images and video or audio recordings provided to them of any Cleanup Assistance activities, including those in which I am depicted, and I waive all rights to compensation by reason of such use.
